Dear Prospective Bidder,

Thank you for your interest in providing gasoline to the City of Cortland for one year beginning April 1, 2019. The City has the need to solicit for bids for gasoline for the Police, Fire and Service Departments. These three departments utilize approximately 1,800 gallons of gasoline and diesel fuel per month.

The City requires the ability to manage the amount of gasoline for each department and will require a fleet system. An individual card for each department will be stored at the facility location for use by a variety of city personnel. The City will require a monthly invoice depicting the following information for each itemized fueling by department; date, time, gallons, gross cost, exempted tax and net cost. The invoice should also contain a summary for each department which provides a total gross cost, total exempted tax, total municipal discount (if applicable) and total net cost. As part of the sealed bid, the City will require an example of an invoice depicting the above information.

Please submit the attached form and requested sample invoice in a sealed envelope to the Clerk of Council at the Cortland Administration Building, 400 North High Street, Cortland, OH 44410 no later than Tuesday, March 19, 2019 at 11:00 a.m. for consideration.
